

Declaration of residence - Annexe B: documentation required to be registered as citizens of European Union countries.

- **Employed or self-employed citizen**

Documents to be submitted

- Copy of a valid ID document for travelling abroad issued by the competent authority of the Country of citizenship and a copy of the tax code. *
- Documents proving employment or self-employment status. *
- Copy of the original acts, translated and legalized, proving marital status and family composition.**

- **Citizen holding sufficient resources to stay (not employed)**

Documents to be submitted

- Copy of a valid ID document for travelling abroad issued by the competent authority of the Country you are citizen of and a copy of the tax code. *
- Self-declaration stating the possession of sufficient resources not to become a burden of the welfare of the State. The reference sum corresponds to the amount of the socials. For the purposes of the registration it is also evaluated the overall situation of the person concerned. *
- Copy of a health insurance that covers health risks nationwide, valid for at least one year, or a copy of one of the following forms issued by the State of origin: E106, E120, E121 (or E 33), E109 (or E 37). * The T.E.A.M. (Tessera europea di assicurazione malattia) or EHIC (European Health Insurance Card) may be used by those who do not intend to transfer their residence in Italy and allows the entry in the temporary population register.
- Copy of the original acts, translated and legalized, proving marital status and family composition.**

- **Student citizen (not employed)**

Documents to be submitted

- Copy of a valid ID document for travelling abroad issued by the competent authority of the Country you are citizen of and copy of the tax code. *
- Record of enrollment in an educational institution or professional training. *
- Self-declaration stating the possession of sufficient resources not to become a burden of the welfare of the State. The reference sum corresponds to the amount of the social. For the purposes of the registration it is also evaluated the overall situation of the person concerned. *
- Health insurance coverage: *
 - for the student who applies for registration in the resident register: copy of a health insurance that covers health risks nationwide, valid for at least one year or at least equal to the duration of the course of study or professional training if less than one year, or an EU form;
 - for the student who applies for registration in the temporary population register: T.E.A.M. (Tessera europea di assicurazione malattia) or EHIC (European Health Insurance Card) issued by the State of origin or an EU form;
- Copy of the original acts, translated and legalized, proving marital status and family composition.**

- **EU family member² of the citizen referred to in the previous paragraphs**

Documents to be submitted

- Copy of a valid ID for travelling abroad issued by the competent authority of the Country you are citizen of and a copy of the tax code. *
- Copy of the original permits of stay, in accordance to the norms on translation and legalization, (e.g. Marriage certificate for the spouse, birth certificate with fatherhood and motherhood for the ancestor or the descendant) * The registration of the family member assumes that the EU citizen is a worker or has sufficient resources to stay for him or herself and his or her family members according to the criteria of art. 29, clause 3, letter b) of the Legislative Decree of July 25, 1998, n. 286, re-evaluated annually.

For all ancestors and descendants over 21 years of age, declaration of being dependent released by the EU Citizen in possession of the rights to stay. *

- **Citizen of a non EU Country, family member of an EU citizen**

Documents to be submitted

- Copy of passport and a copy of the tax code *
- Residence permit of an EU citizen's family member, or receipt of the application for issuance of the residence permit.*

(1) Article 7, clause 3 of Legislative Decree no. 30/2007

The citizen of the EU, already employed or self-employed on the national territory, has the right to stay according to clause 1, letter a) when the following conditions occur:

- She/he is temporarily unable to work due to an illness or accident;
- She/he has a duly recorded status of involuntary unemployment after having been employed for over a year in the Country and is registered at the Employment Office, that is she/he has made the declaration according to the Article 2, clause 1 of Legislative Decree 21 April 2000, n. 181, as amended by the Article 3 of Legislative Decree 19 December 2002, n. 297, attesting the immediate availability to work;
- She/he has a duly recorded status of involuntary unemployment at the end of a temporary contract with a duration of less than one year, that is she/he became redundant within the first 12 months of residence in the national territory, is enrolled at the Employment Office and she/he has made the

declaration according to the Article 2, clause 1 of Legislative Decree 21 April 2000, n. 181, as amended by the Article 3 of Legislative Decree 19 December 2002, n. 297, at testing the immediate availability to work. In such a case, the person concerned shall retain the status of employee for a period of one year;

- She/he attends a course of professional training . Except in the case of involuntary unemployment, the retention of the status of worker shall require a link between the previous employment and the attended training course.

²EU citizen's family member can refer to: the spouse, the direct descendants under the age of 21 or dependents and those of the spouse; the direct dependent relatives in the ascending line and those of the spouse (art. 2 of Legislative Decree N. 30/2007).

** Required documentation for the registration of the family relationship and the release of certification at the Registry Office.
